





3. The School Authority shall submit the Latest Test Report issued from Delhi Jal Board within 60 days from the date of granting of provisional up-gradation.
4. That school shall pay salary and other admissible allowances to its teaching and non-teaching staff as per on-going CPC through Bank/RTGS and not in cash.
5. The school shall comply with all the provisions of DSEAR, 1973, RTE Act, 2009, the DRTE Rules, 2011 and directions/instructions/guidelines issued by the Education Department and other Departments from time to time. The school shall also implement Orders of difference Courts/Tribunals/Statutory Authorities issued from time to time.
6. The school shall comply with the provisions of Rules 176, 177, 18(5), 17(3) & orders dated 15.12.1999, 10.05.2005, 11.02.2009, 16.04.2010 & 19.02.2016 dealing with the regulation of fee along with the subsequent orders issued by DoE time to time.
